Dear Valued Shareholders of DKSH Holdings (Malaysia) Berhad,

DKSH HOLDINGS (MALAYSIA) BERHAD ("DKSH Malaysia" or "the Company") Twenty-Ninth Annual General Meeting ("29th AGM")

In view of the ongoing pandemic and as part of the safety measures, the Board of Directors of the Company has decided that the 29th AGM of the Company will be conducted entirely through live streaming from the Broadcast Venue at Tricor Business Centre, Manuka 2 & 3 Meeting Room, Unit 29-01, Level 29, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur ("Broadcast Venue") on Wednesday, June 16, 2021 at 10:00 a.m. using the Remote Participation & Voting ("RPV") Facilities provided by Tricor Investor & Issuing House Services Sdn Bhd via its TIIH Online website at https://tiih.online.

The 29th AGM of the Company will be carried out in the manner as guided by the Securities Commission Malaysia Guidance on the Conduct of General Meetings for Listed Issuers dated April 18, 2020 and revised on March 5, 2021 ("SC Guidance"). Pursuant to the SC Guidance and Section 327 (2) of the Companies Act, 2016, the Chairman shall be present at the Broadcast Venue of the AGM to chair the AGM. Shareholders will **NOT** be physically present at the Broadcast Venue on the day of the AGM. However, shareholders who intend to attend, participate, speak (in the form of typed text messages) and vote remotely at the 29th AGM are required to register via TIIH Online website at https://tiih.online by using the RPV according to the procedures set out in the Administrative Guide.

If you wish to appoint a proxy to attend and vote on your behalf at the 29th AGM, please refer to the procedures for such appointment in the Administrative Guide. You must also be a registered user of **TIIH Online** if you choose to submit the proxy form or corporate representative certificate by electronic means for such appointment and indicate your voting instructions therein.

A shareholder who has appointed a proxy or attorney or authorized representative to attend, participate, speak and vote at this AGM via RPV must request his/her proxy or attorney or authorized representative to register himself/herself for RPV at TIIH Online website at https://tiih.online in accordance with the procedures as set out in the Administrative Guide.

The Annual Report, Circular to Shareholders and Corporate Governance Report ("AGM documents") dated May 6, 2021 have been published on the Company's website at www.dksh.com.my. You may download the soft copy of the AGM documents from our website. The Notice of the AGM, Proxy Form and Administrative Guide are included together with this letter for your information.

In view of the ongoing pandemic and as part of the safety measures, the Board of Directors of the Company has decided that the 29th AGM of the Company will be conducted entirely through live streaming from the Broadcast Venue. This is line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on April 18, 2020 and revised on March 5, 2021.

The Broadcast Venue and time of the 29th AGM shall be as set out below:

The Broadcast Venue is strictly for the purpose of complying with Section 327 (2) of the Companies Act 2016 ("CA 2016") which stipulates that the Chairman shall be at the main venue of the 29th AGM. Hence, shareholders **WILL NOT BE ALLOWED** to attend the 29th AGM in person at the Broadcast Venue on the day of the meeting.

REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

The RPV facilities are available on Tricor Investor & Issuing House Services Sdn Bhd's ("Tricor") **TIIH Online** website at https://tiih.online.

Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 29th AGM using RPV facilities from Tricor.

Shareholders who appoint proxies to participate via RPV in the 29th AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor **no later than Monday, June 14, 2021 at 10:00 a.m.**

Corporate representatives of corporate members must deposit their original certificate of appointment of corporate representative to Tricor **no later than Monday, June 14, 2021 at 10:00 a.m.** to participate via RPV in the 29th AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor **not later than Monday, June 14, 2021 at 10:00 a.m.** to participate via RPV in the AGM.

A shareholder who has appointed a proxy or attorney or authorized representative to attend, participate, speak and vote at this Annual General Meeting via RPV must request his/her proxy or



attorney or authorized representative to register himself/herself for RPV at TIIH Online website at https://tiih.online

PROCEDURES FOR RPV

Shareholders/proxies/corporate representatives/attorneys who wish to participate at the 29th AGM remotely using the RPV are to follow the requirements and procedures as summarized below:

(b)	Submit your request	 Registration is open on Thursday, May 6, 2021 at 10:00 a.m. until the day of 29th AGM on Monday, June 14, 2021. Shareholder(s), or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 29th AGM to ascertain their eligibility to participate the 29th AGM using the RPV. Login in with your user ID (i.e. e-mail address) and password and select the corporate event "(REGISTRATION) DKSH 29TH AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting". Review your registration and proceed to register System will send an e-mail to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as at June 9, 2021, the system will send you an email after June, 14, 2021 to approve or reject your registration for remote participation. (c)	Login to TIIH Online	• Login with your user ID and password for remote participation at the 29 th AGM at any time from 9:00 a.m. i.e. 1 hour before the commencement of 29 th AGM at 10:00 a.m. on Wednesday, June 16, 2021.	
(d)	Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) DKSH 29th AGM" to engage in the proceedings of the meeting remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavor to respond to questions submitted by remote participants during the 29th AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting. 	



(e)	Online Remote Voting	 Voting session commences from 10:00 a.m. on Wednesday, June 16, 2021 until a time when the Chairman announces the end of the voting session of the 29th AGM. Select the corporate event: "(REMOTE VOTING) DKSH 29th AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting.
(f)	End of remote participation	 Confirm and submit your votes. The Live Streaming will end upon the announcement by the Chairman on the closure of the 29th AGM.

Note to users of the RPV facilities:

- 1. Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

Proxy

In view that the 29th AGM will be conducted on a virtual basis, members who are unable to participate in this AGM may appoint the Chairperson of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

If you wish to participate in the 29th AGM yourself, please do not submit any Proxy Form for the 29th AGM. You will not be allowed to participate in the 29th AGM together with a proxy appointed by you.

Accordingly, the proxy forms and/or documents relating to the appointment of proxy/corporate representative /attorney whether in hardcopy form or electronic means shall be deposited in the following manner not later than Monday, June 14, 2021 at 10.00 a.m.

Poll Voting

The voting at the 29th AGM will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad of Main Market Listing Requirements. The Company has appointed Tricor Investor & Issuing House Services Sdn Bhd as Poll Administrator to conduct the poll by way of electronic means and Asia Securities Sdn Berhad as Scrutineers to verify the poll results.

Shareholders can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and **submit your votes at any time from the commencement of the 29th AGM at 10:00 a.m.** Kindly refer to item (e) of the above Procedures for RPV Facilities for guidance on how to vote remotely from TIIH Online website at https://tiih.online. The Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.

Pre-meeting submission of questions to the Board

In order to enhance the efficiency of the proceedings of the 29th AGM, shareholders may submit questions for the Board in advance of the 29th AGM via TIIH Online website at https://tiih.online by selecting "e-Services" to login, pose your questions and submit electronically **no later than Monday, June 14, 2021 at 10:00 a.m.** The Board will endeavor to answer the questions received at the AGM. All relevant questions and answers will be uploaded to the corporate website upon the completion of AGM in due course.
